NEW ARBITRATION RULES FOR TRUSTS, ESTATES AND FOUNDATIONS

The webinar provides a concise introduction to the core features and advantages of arbitration, then presents the new Swiss arbitration rules specifically designed for disputes involving trusts, estates and foundations. Participants will learn about the distinctive features and benefits of these new rules and will gain practical insights into key considerations when choosing arbitration to resolve trust, estate or foundation disputes. The session will finish with a Q&A to address participants' questions and discuss real-world issues.



Benjamin Gottlieb is a Partner in the Dispute Resolution Group at Schellenberg Wittmer Ltd. His main areas of practice are international arbitration as well as domestic and international commercial litigation. He further specializes in and advises clients on the United Nations Convention for the International Sales of Goods (CISG). He is also a lecturer at the University of Zurich for international commercial arbitration, contract law and the Vienna Sales Convention and taught advocacy classes in Milan.





David Wallace Wilson is a Partner at Schellenberg Wittmer, where he heads the Geneva private wealth group.

Admitted to the Swiss and NY bars, David advises clients on wealth structuring and estate planning; he also acts in complex family, guardianship and inheritance disputes.
