# FROM THE ALPS TO THE ENGLISH CHANNEL: SWISS MARRIAGE CONTRACTS AND ENGLISH PRE-NUPTIAL AGREEMENTS

<u>Description</u>: This will be a discussion of best practice in planning marriage contracts which need to work in the context of potential divorce in Switzerland and England.



**Nicholas Bennett** is an English lawyer whom the *Chambers* and *Partners* directory describes as "the go-to barrister for prenuptial agreements".

Nick is recognised in the legal directories as one of the country's leading experts in pre- and post-nuptial agreements. He drafts them; reviews those drafted by others; and litigates divorce cases which concern them.
